## Narrative

A report of trespassing was made on the 4200 block of Cocolalla Loop.

Probable Cause Statement:

Due to previous issues at the Cowboy Church in Cocolalla, Dennis Marquez requested a deputy present to trespass Julie Delano. While on scene to do so Scott Herndon and Arlene Herndon got into an argument with church staff and they were asked to be trespassed as well. All three were notified they were trespassed from the church for a year. Report to follow.

#### Narrative:

On 04/25/21 at approximately 0824 hours, I was dispatched to contact Dennis Marquez, who works as security at 4281 Cocolalla Loop (The Cowboy Church). Dennis was calling as a series of previous events at the church caused him concern that several citizens may show up and be confrontational, for which they would be trespassed from the church grounds. I am familiar with the parties involved. One of whom, Julie Delano, spoke to me on 4/19/2021, regarding an issue she had with the church on 4/18/2021. See report 21-007180 for additional information on that contact.

Shortly after I spoke to Julie, advising her she was trespassed from the church property, Dennis alerted me to another issue that was starting in the parking lot as well. As I rounded some parked cars I noted Scott Herndon who had shown up to the church, was being asked to leave. Scott was being verbally confrontational with church staff and when I tried to speak to him he demanded to speak to pastor Steven Bradshaw. I attempted to explain to Scott that Steven did not have to come out to speak to him, but I would seek him out and see if he would come explain why Scott and his wife, Arlene, were not welcome at the church. I know some background with the Herndon family, though I cannot recall ever meeting Scott or Arlene in the past.

Of relevance as it was explained to me:

- Scott has a nephew, Christopher Herndon
- Scott has a niece named Anastasia Herndon
- On 3/27/2021, Christopher was arrested for Unlawful Entry after Anastasia left Scott's brother's residence (Paul Herndon) who resides at 222 Otts Basin Road following a conflict with her family.
- Anastasia had taken shelter with a neighbor, Marcy Ott, whose home Christopher unlawfully entered resulting in a protection order issued protecting

Marcy from contact by Christopher (order #33528).

The church security told me it was their opinion that Scott, Arlene, and their family were coming to the church in order to menace Marcy and Anastasia. When Steven came out to try to speak to Scott and Arlene they continued to be confrontational and levied statements toward Steven that didn't seem connected with the issue (at one point accusing Steven, I believe, to be trespassing them due to the Black Lives Matter movement). It became clear Scott and Arlene weren't going to have a discussion about why they were being trespassed and Steven walked away telling both of them they were trespassed from the church grounds. Scott and Arlene departed shortly thereafter and I did not contact them again.

I remained on scene at the church as there was a third matter completely unrelated to any of the aforementioned parties. After a short amount of time with things having calmed down I cleared. It was noted in all three parties name files they were trespassed from the church for one year.

### Narrative

Follow up was requested on a previous Bonner County case.

Scott Herndon called as he was confused why I was present when his family showed up to the Cowboy Church. Scott thought I had responded there to confront his family and didn't realize he was going to be being trespassed. Scott was told that I had shown up to the church for reasons unrelated to his family, and it wasn't until I heard the commotion in the parking lot that I knew I was going to be trespassing him. Scott was frustrated as he wished the church had just called his family and told them they weren't welcome rather than confront them in the parking lot. After our conversation Scott seemed to understand I was simply doing my job as the church wanted him trespassed. I apologized for the confusion around the contact. Scott assured me he and his family would not be returning to the church, as it was now clear they weren't welcome.
